Advertisement: (1) PRN Telehealth Psychiatrist Contract

Request for Applications will be accepted by North Mississippi State Hospital until January 28, 2026, 5:00 p.m. CST, for the purpose of hiring one (1) Board Certified/Board Eligible (Telehealth) PRN Psychiatrist to work as a Contract Worker. The physician will serve as Telehealth and/or On-Site Psychiatric Physician **RFX 3150006655**. Duties include but are not limited to providing psychiatric care to patients/residents/clients during and after hours, weekends, and holidays. Minimum qualifications: Verifiable Doctor of Medicine Degree or Doctor of Osteopathic Medicine Degree from an accredited medical school; verifiable completion of at least two (2) years of psychiatric medicine, family medicine, or internal medicine residency program; a verifiable current, unrestricted license to practice medicine in the State of Mississippi; a verifiable current registration certificate issued by the Drug Enforcement Administration (DEA). The applicant must submit at least two (2) references from peers with current knowledge of applicant's clinical practice.

Prior to an offer of employment, the applicant must provide a copy of a professional liability Insurance policy with coverage of at least \$1,000,000 inclusive per occurrence and \$3,000,000 aggregate; be credentialed by the MSH Medical Staff, have satisfactory results from a criminal background check and have satisfactory results from a urine drug screen. The contract worker will work up to an average of 20 hours per week with an hourly rate of \$200.00. The contract will extend from March 1, 2026, to June 30, 2030.
